The title and maker's name should appear on the back. Any card, which has the title and/or maker's name on the front, will have that information taped over for the judging.
- 3. Entries must originate as photographs (images-captures of objects via light sensitivity) made by the entrant on photographic emulsion or acquired digitally. By virtue of submitting an entry, the entrant certifies the work as his own and permits the sponsors to reproduce all or part of the entered material free of charge for publication and/or display in media related to the exhibition. This may include low resolution posting on a website. The exhibition assumes no liability for any misuse of copyright (Submission implies acceptance of all conditions).
- 4. Images may be altered, either electronically or otherwise, by the maker and artwork or computer graphics created by the entrant may be incorporated if the photographic content predominates.
- 5. All final work must be on photographic film or on photographic or electronic print material, mounting excepted.
- 6. Images previously accepted may not be reentered regardless of title.
- 7. An entrants four images will be distributed throughout four rounds of judging.
- 8. Selection will follow the current Photographic Society of America's (PSA) Consolidated Exhibition Standards (CES) and PSA Uniform Judging Practices.
- 9. All entries must be sent prepaid using the enclosed shipping label, entry form, labels and entry fee enclosed with entries.
- 10. On the back of each stereo card the title (as it appears on the entry form), the name of the maker and the number to conform to the entry form must appear. View in which proper orientation is not obvious (e.g. abstracts) should be marked on the back as to which way is up.
- 11. All accepted cards will be credited to the entrants at the showings and in the catalog. Names of entrants of accepted cards will be submitted for listing credit in PSA's "Who's Who in Stereo Photography" and for Star Rating records.
- 12. Score reports will be emailed, unless a written copy is requested.
- 13. Domestic entries returned First Class Mail & foreign entries, Air Mail.
- 14. All possible care will be exercised in handling of all entries, but no responsibility is assumed for loss or damage of entries during the Exhibition or in transit.
